• Spirits are shelf-stable at ambient temperature 21°C

Denatured spirits should simmer with the food, marinade or sauce to enhance the flavor of the dish. As the ingredient cooks, it reduces and becomes an extract which flavors the food.

Cook the food at least 20 to 30 seconds after adding the denatured spirit to allow the alcohol to evaporate. Since alcohol evaporates at 172° (78°C), any sauce or stew that is simmering or boiling is certainly hot enough to evaporate the alcohol.
